- We will collect personal information by lawful and fair means with the knowledge and consent of the individual(s) concerned.

- Personal data should be relevant to the purposes for which it is to be used, and, to the extent necessary for those purposes, should be accurate, complete, and up to date.
- We will protect personal information by reasonable security safeguards against loss or theft, as well as unauthorised access, disclosure, copying, use or modification.
- We will make readily available to user's information about our policies and practices relating to the management of personal information.
- If we need to provide you with information about something, whether for legal, marketing, or other business-related purposes, we will select what we believe is the best way to get in contact with you. We will usually do this through email.

### **Your acceptance of this privacy policy**

Your continued interaction with The Nichols Group and its products, services and events means that you are happy for us to use your personal information as described in this policy.

### **What we collect and how we use it**

This policy covers information about or linked to a natural person (personal information). It includes data we obtain from you, like your name, email address, phone number, IP address, or mobile device's operating system type, and may include financial information. It also includes correspondence and communication data.

### **When do we collect your personal information?**

You may provide us with personal data, when you use our services; and communicate with us (whether through email, post or by phone).

### **Why do we collect your data?**

Should we acquire your information via a third party, we will notify you of this.

## Do we share your information?

We will not sell or lease your personal information. We may share your personal data with our affiliates (for example, where they provide services on our behalf) or where such sharing is otherwise necessary in accordance with the uses set out below.

We may share your personal data with third party vendors and other service providers that perform services for us or on our behalf, which may include providing advertising, marketing, data hosting, Customer Relationship Management, IT system administration, payment and analytics services. In addition, we may share your personal data with other third parties if you have provided your consent for us to do so.

Your personal data may be disclosed to third parties in connection with a transaction, such as a merger, sale of assets or shares, reorganisation, financing, change of control or acquisition of all or a portion of our business.

We may share your personal data with third parties as required by law or if we reasonably believe that such action is necessary to:

## **Data retention, storage and international data transfers**

### **Data retention**

We will keep personal information only for as long as we need it to maintain our relationship with you or to provide information you requested, to comply with the law, and to ensure we do not communicate with individuals that asked us not to. We may also keep personal information. When we no longer need the information, we will dispose of it securely or delete accordingly.

To determine the appropriate retention period for personal data, we consider:

- the amount, nature, and sensitivity of the personal data
- the potential risk of harm from unauthorised use or disclosure of your personal data
- the purposes for which we process your personal data
- whether we can achieve those purposes through other means
- the applicable legal, regulatory, tax, accounting, or other requirements

### **Storage and international data transfers**

Nichols will always attempt to use UK based storage to keep the personal information we have. We may also store information in paper files. We use appropriate technical and organisational security measures including encryption and access control to protect personal data from unauthorised use, loss, alteration, or destruction. Where data processing is carried out on our behalf by a third party, we take steps to ensure that appropriate security measures are in place to prevent unauthorised disclosure of personal data.

Despite these precautions, however, we cannot guarantee that unauthorised persons will not obtain access to personal data.

We may transfer personal information to reputable third-party organisations situated inside or outside the European Economic Area. These organisations are required to safeguard personal information pursuant to their contractual obligations or participation in international data transfer mechanisms. ## **What are your rights?**

### **Access**

You have the right to request us to provide you details of the personal information we hold about you. We will take no longer than 30 days to complete the request and we are obliged to fulfil this request for free, however, The Nichols Group reserve the right to charge a 'reasonable fee' for requests that are unfounded or excessive, particularly if it is repetitive. We may also charge a 'reasonable fee' to comply with requests for further copies of the same information. This does not mean that we will charge for all subsequent access requests. ### **Data portability**

You have the right to ask us to provide you (in a structured, commonly used, and machine-readable format without hindrance) personal information about you that we have which you had provided to us. You may ask us to transmit it directly to another controller if it is technically feasible.

### **Correction**

You have the right to ask us to correct our records if you believe they contain incorrect or incomplete information about you.

### **Erasure**

You have the right to erasure (deletion), without undue delay, of your personal information for which you later withdraw your consent to processing, or when it is no longer needed for the purpose it was originally collected. Data records required by law will be kept in some circumstances.

### **Processing restrictions**

You have the right to temporarily restrict our processing of your personal information if: you contest the accuracy of your personal information; you prefer we restrict its use rather than erase it; you need it to be preserved to establish, exercise, or defend a legal claim; whilst you are verifying whether we have overriding legitimate grounds to use it. You have the right to be informed before we lift the processing restriction.

### **Object**

You have a right to object to the processing of your personal data that we carry out on the basis of legitimate interests in certain circumstances. You can also object to our marketing activities for any reason by reply to the email with the subject 'REMOVE' or clicking the unsubscribe link set out within any marketing communications.

### **Withdraw Consent**

If you have provided consent to any processing of your personal data, you have a right to withdraw that consent.

### **Automated individual decision-making**
